Terms of Reference

As the HIV and TB epidemics in Nigeria evolve, certain groups or sub-populations continue to experience high disease burdens, poor health outcomes, human rights violations, poor access to justice and other serious issues despite the significant expansion of the national responses over the last decade. In addition, there are many structural level factors that increase vulnerability to HIV and TB, these include serious challenges related to the protection and promotion of human rights for those most at risk of acquiring HIV or TB, and the significant negative public health consequences this entails individually and collectively. In services provision, components of access to justice are not available in all locations. The law enforcement and other duty bearers need to address stigma and discrimination among other human rights violations in the provision of services.

Key stakeholders across all sectors of the multi-sectoral HIV and TB responses in Nigeria are intensely aware of the presence and effects of human rights and gender-related barriers and are fully engaged in programmes to reduce or remove them. Despite such efforts, however, progress to improve the effectiveness and impact of HIV and TB programmes across all population groups, in all their diversity, remains less than optimal.

In view of these and to ensure greater achievement of the set goals of the national response, there is need for capacity strengthening of the officers of Nigeria Police Service to integrate interventions to remove barriers to HIV and TB services for public health promotion and protection.

1. Objective of the engagement

• To review/revise TORs for Police Action Committee on AIDS (PACAs) to be inclusive of internal/external roles for NPS in national HIV and TB responses.

2. Tasks for the consultants

Under the technical guidance and overall supervision of the Gender and Human Rights Care Support Service division, the consultants will:

- Sharing of existing GHR-SRT ToR with key stakeholders
- Collation of comments and recommendations.
- Drafting of the revised PACA ToR that is inclusive of internal/external roles for NPS in national HIV and TB responses.
- Sharing and collation of inputs from stakeholders on the draft ToR.
- Finalization of the of the ToR.

3. Expected Deliverable

 Reviewed/revised TORs for Police Action Committee on AIDS (PACAs) inclusive of internal/external roles for NPS in national HIV and TB responses.

4. Experience/Qualification of the Consultant

The requisite qualifications of the Consultant shall include the following:

- At least Master's Degree in public health or social sciences with specialization in gender, human rights or sexual and reproductive health
- At least 5 years' experience in HIV/key population must be familiar with health and non-health sector HIV/AIDS, TB and/or Malaria
- Demonstrate good understanding of the HIV/AIDS, KP programming in sub-Saharan Africa and in Nigeria in particular
- Should have undertaken at least one (1) similar assignment in the last two years with letter of award or job completion certificate as evidence..
- Ability to communicate ideas in a manner conducive to their practical application and comfortable working as part of a team to add value to collective results
- Good team worker and result-driven
- Excellent facilitation, communication and writing skills is essential
- Excellent analytical skill is essential
- Excellent interpersonal skill is desirable.

5. Duration of consultancy

The consultancy shall work over a period of 10 days to deliver the entire process.

REMUNERATION

The consultants will be paid based on the approved Global Fund budget for all the activities on a basis on a verified report.
