1. Background and Context

HIV/AIDS remains a significant public health challenge in Nigeria. Pre-Exposure Prophylaxis has emerged as an effective biomedical prevention strategy that can significantly reduce the acquisition of HIV among at-risk populations. Pre-Exposure Prophylaxis (PrEP), consisting of antiretroviral drugs taken by HIV-negative individuals, has been widely recognized as an efficacious preventive measure, for KPs (such as MSM, TG, sex workers, and PWID) and sero discordant couples. Several research findings have shown high indications that PrEP significantly reduces the risk of HIV infection when taken consistently and correctly.

One of the primary strategic objectives of the National Agency for the Control of AIDS, (NACA) is to effectively decrease the occurrence of new HIV infections by improving the availability and utilization of HIV prevention, intervention, and prophylactic measures. It is therefore imperative to measure the impact PrEP has had on the prevention of new HIV infection in Nigeria over the years.

2. Objectives of the Assignment

The overall objective of this study is to assess the contribution and impact of the uptake of preexposure prophylaxis (PrEP) and other HIV prevention interventions on reducing new HIV infections in Nigeria, while also examining factors influencing their adoption, accessibility, and effectiveness across different populations and settings.

3. Scope of Work

Consultant will be responsible for the following tasks:

- . Review relevant documents including grant performance frameworks, implementation plans, and progress reports.
- 2. Conduct field assessments across selected sites to evaluate the outcomes of infrastructural upgrades, QMS implementation, and EQA participation.
- 3. Collect and analyze quantitative and qualitative data to assess improvements in laboratory performance and systems functionality.
- 4. Evaluate the impact of the integrated sample referral pilot using NIPOST in two states.
- 5. Prepare intervention-specific technical reports and develop manuscripts for publication in peer-reviewed journals.
- 6. Facilitate validation workshops with key stakeholders

3.1 Study Area

This evaluation is expected to take place in twelve (12) states of the country, two states in each geo-political zone. (Anambra, Akwa Ibom, Gombe, Benue, Ebonyi, Rivers, Kaduna, Nasarawa, Lagos, Ondo, Adamawa and Kano) in the country.

The evaluation will take place in locations where KPs and sero-discordant couples receive PrEP,. One Stop Shop (OSS) facilities will be assessed in states where they are still functional. Sero-discordant couples who have used PrEP will also be purposively reached through Health facilities and IPs supporting those facilities.

Furthermore, states KP Secretariat offices will be used to reach the community members accessing PrEP. NEPWAN offices will also be used to increase the participation of sero-discordant couples in the evaluation. IPs involved in Kabele study, will enable access to pregnant women on this study. The , Kabele study participants (pregnant women using PrEP) will also be assessed. SACAs and SASCP in the 12 states coordinating PrEP implementation will be assessed.

3.2 Study population

Criteria for selection: All participants in the study must belong to the study population. They must be 18 years and above and must have taken PrEP for at least 6 months or have provided PrEP services for at least 6 months.

- -FSW
- -PLWID
- -TG
- -Sero-discordant couples
- -Pregnant women using PrEP

PrEP implementers – NACA, FMOH, SACA, SASCP, IPs, KP groups, ASHWAN, health workers

3.3 Evaluation design

3.3.1 THEORY OF CHANGE

This evaluation will be use the theory of change design to provide a roadmap for understanding how and why the PrEP and other prevention interventions lead to desired outcomes. In the context of this evaluation, this design will serve as a framework for analyzing whether PrEP intervention is achieving its intended outcomes. It will also help us to determine if the expected causal relationships between activities, outcomes, and impacts are actually happening.

3.3.2 EVALUATION MATRIX

An evaluation matrix will be utilized to assess the effectiveness, efficiency, impact, and sustainability of PrEP interventions in Nigeria (OECD/DAC). This matrix will include evaluation questions, subquestions, indicators, and data sources, guiding data collection, analysis, and the development of

evaluation findings. This will provide a structured framework for decision-making by organizing information and ensuring objectivity.

3.3.3 PRE AND POST ANALYSIS

The country and state-level HIV incidence from Global AIDS Monitoring reports and other sources before and after the uptake of PrEP will be compared to determine the impact of PrEP on prevention of new infections.

3.3.4 COST EFFECIVENESS ANALYSIS

Expenditure on PrEP and other Prevention initiatives (condoms, etc.) will be extracted from NASA & other programmatic reports and evaluated against program outputs/ results to determine efficiency. This analysis will demonstrate the relationship between spending on PrEP and other prevention interventions and changes in program metrics.

3.5 Evaluation Questions

Effectiveness

- 1. What is the effect of taking PrEP?
- 2. Is PrEP service working? And why?
- 3. What are the results achieved through PrEP intervention?
- 4. How has PrEP contributed to HIV prevention and response?
- 5. What difference has PrEP brought to HIV prevention, compared with before PrEP intervention?
- 6. Were beneficiaries satisfied with the PrEP services? If not, why not?
- 7. What is the rate of HIV seroconversion among individuals on PrEP, and what factors are associated with breakthrough infections?
- 8. Are drug resistance patterns emerging among individuals who seroconvert while on PrEP?
- 9. What are the side effects and tolerability levels of PrEP among different study groups?

Adherence

- 1. What proportion of PrEP users maintain adherence over 3-, 6-, and 12-month post-initiation?
- 2. How effective are current adherence support mechanisms (e.g. counseling, SMS reminders, peer support) in promoting consistent PrEP use?
- 3. What are the common barriers and facilitators to sustained PrEP adherence among users?
- 4. How does adherence vary by key population groups (e.g. adolescent girls and young women, MSM, sex workers)?
- 5. What is the relationship between PrEP adherence and retention in HIV prevention services?
- 6. To what extent are PrEP users receiving regular follow-up and monitoring as recommended in national guidelines?

Efficiency (Cost Effectiveness)

1. How cost-effective is PrEP compared to other HIV prevention strategies in the current landscape of HIV response direction?

Accessibility

1. Percentage of KPs, Sero discordant couples and pregnant women currently on PrEP in the study areas.

Sustainability

- 1. What strategies and structures are required or are in place to ensure the long-term availability and accessibility of PrEP services for KPs in Nigeria?
- 2. Are PrEP services integrated into routine health systems and national HIV prevention programs?
- 3. Do health facilities have the capacity (staff, supply chains, infrastructure) to continue delivering PrEP services sustainably?
- 4. Is there a financial plan or transition strategy to shift PrEP service delivery to local or national funding?

Program Improvement

- 1. What aspects of PrEP services need to be improved?
- 2. Lessons learned and recommendations
